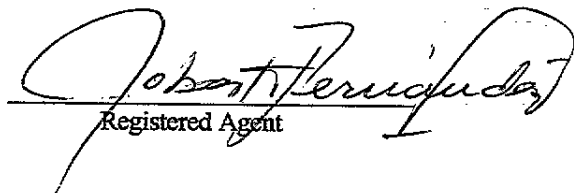

ARTICLES OF INCORPORATION OF BIROT-LAB, INC.

ARTICLE ONE

The name of the corporation is **BIROT-LAB, INC.**

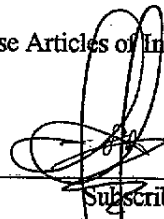

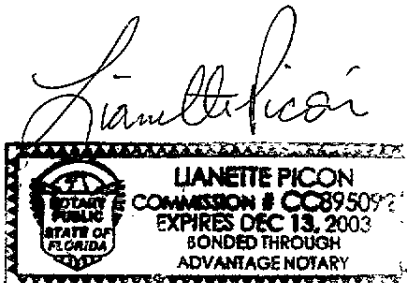
