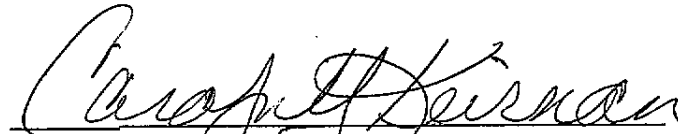
ARTICLE VIII-INDEMNIFICATION

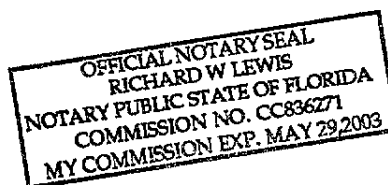

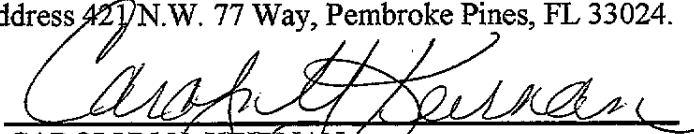
