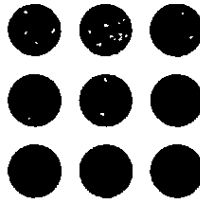

It also appears that this individual is fraudulently trying to claim a portion of the surplus funds from the City of Coral Gables which is owed to me.

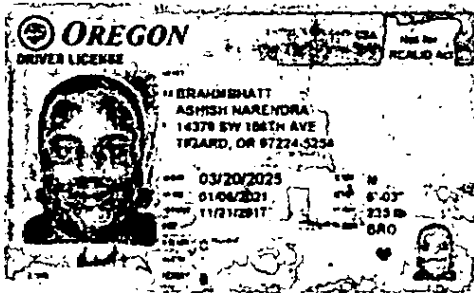

Mrs. Delancy was a prior owner of the property along with her siblings who sold the home to me and became my tenant. In no way is she entitled to any proceeds from the surplus funds. Mr. Gutierrez also has no claim to the surplus funds either and any reference made to interest in a mortgage is untruthful as the public record clearly reveals.
