# **ARTICLES OF INCORPORATION**

SERETARY OF 4:34 The undersigned, acting as Incorporator of a corporation under the Florida Bi Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE ONE

#### **NAME**
