Articles of Incorporation

In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

Article I. The name of the corporation shall be:
Sweet Construction, Inc.

Article II. The principal place of business of the corporation is:

Article III. The purpose of the corporation is to subcontract work from licensed underground utility and general contractors.

Article IV. The corporation shall have the authority to issue one class of stock, that being **1000** shares of no par value, common stock, with identical rights and privileges, the transfer of which is restricted according to the bylaws of the corporation.


Article V. The initial Board of Directors shall have **two (2)** members whose names and addresses are as follows:
