ARTICLE I - Name

The name of this corporation is:

ARTICLE IX - Purpose or Purposes

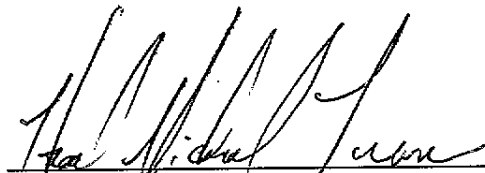

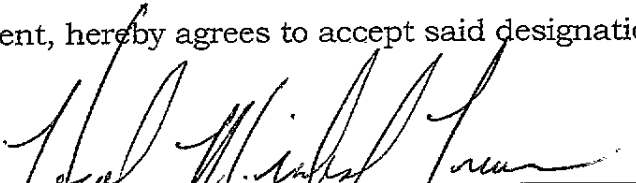

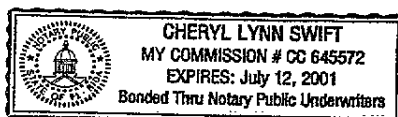
