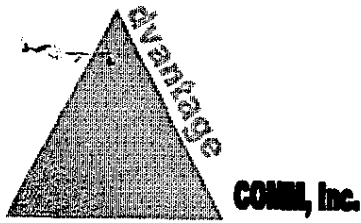


This letter is to request the reinstatement of corporate status to Advantage Communications and Consulting Services and to request a waiver of the reinstatement fee of \$600.00.
