SECRETARY OF STATE TALLAHASSEE, FLORIDA We, the Undersigned hereby associate ourselves together for the purpose of becoming a corporation under the laws of the STATE OF FLORIDA providing for the formation, liability, rights, privileges and immunities of corporation for profit.

#### ARTICLE I, NAME

# ARTICLES II, NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida

# ARTICLE III, CAPITAL STOCK
