The undersigned, acting as incorporators of a Florida corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation.

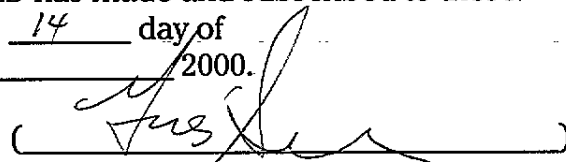
