CERTIFICATE OF INCORPORATION

We, the undersigned, in order to form a Corporation for profit for the purpose hereinefter stated, under and pursuant to the provisions of the Florida Statutes, do hereby subscribe to this certificate of Incorporation, and do adopt the following Articles of Incorporation:

ARTICLES OF INCORPORATION

ARTICLE

The name of the Corporation shall be:

La Voz de la America Central Inc.

ARTICLE !!

The general nature of the business and the objects and purposes to be transacted and carried on by this Corporation shall be:

- (a) This Corporation is organized with the purpose to engage in the <u>Radio Station News</u> business and all other lawful activities permitted under the laws of the State of Florida and the United States of America.
- b) To enter Into, make and perform contracts of every kind, for any lawful purpose, without limit as to amount, with any person, firm association or corporation, town, city, country, state, territory or government.
- c) To purchase or otherwise acquire, and to hold, own, maintain or otherwise dispose of and deal in lands and leaseholds, and any franchises, rights in real property, and personal or mixed property, and any rights, licenses or privileges necessary, convenient or appropriate for any of the purposes herein expressed and to have any and all powers above set forth as fully as natural person, whether as

principals, agents trustees or otherwise.
