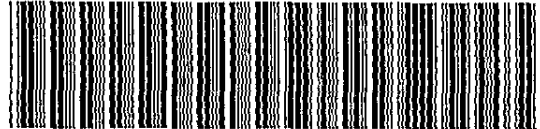

Pursuant to Section 607.1001, Florida Statutes, the Articles of Incorporation of the above-named Corporation are amended as follows:

1. Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

“Article I. Name. The name of the Corporation is Stagg Landscaping, Inc. The principal office of the Corporation is 2819 Scarlet Road, Winter Park, Florida 32742, and the mailing address of the corporation is 20 N. Orange Avenue, Suite 600, Orlando, Florida 32801.”

2. Pursuant to Section 607.1003, Florida Statutes, the foregoing amendment was proposed to the Sole Shareholder by the Board of Directors and the number of votes cast for the amendment by the sole shareholder was sufficient for approval, and the amendment was adopted on October 15th, 2005.

3. The effective date of these Articles of Amendment shall be the date filed with the Florida Department of State.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
