INITIAL AND PRINCIPAL REGISTERED OFFICE AND AGENT

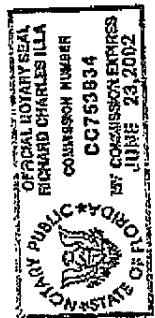

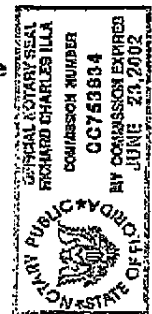

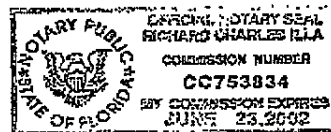
