ARTICLES OF INCORPORATION
OF

The undersigned incorporators, for the purposes of forming a corporation under the Florida Business Corporations Act, Chapter 607, Florida Statutes, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I. NAME AND PRINCIPAL ADDRESS

The name of the corporation shall be USA TOURS & CHARTER SERVICES, INC.. The principal address of the Corporation will be 3600 South State Road 7, Miramar, FL 33023. The mailing address shall be the same.

ARTICLE II. DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

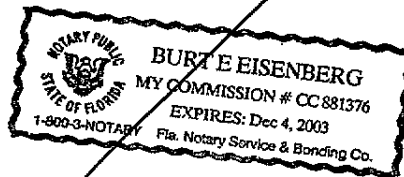

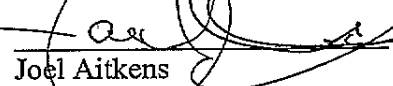
