ARTÍCLES OF INCORPORATION OF ELITE INVESTMENT PROPERTIES, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

1.01. The name of the corporation shall be:

ARTICLE VI BOARD OF DIRECTORS
