ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Afficles of Incorporation of such corporation:

ARTICLE I - NAME AND PLACE OF BUSINESS
