The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

Article 1 - Name

The name of the corporation is Malborough Florida Holdings Corp.

Article 2 - Mailing Address and Principal Office
