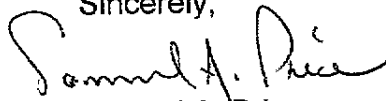

**ARTICLES OF CORPORATION**  
**OF**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I - Name.** The name of the Corporation shall be SON WAY DISTRIBUTERS, INC.

**ARTICLE II - Address.** The address of the principal office of the corporation is 7908 N.W. 53rd Court, Lauderhill, Florida 33351.

**ARTICLE II - Purpose.** The general purposes for which the corporation is organized are the following:
