ARTICLE I. NAME

The name of this corporation shall be G. C. DePalma, P.A.



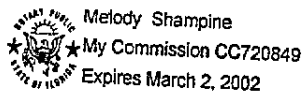



