**ARTICLES OF INCORPORATION**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

**ARTICLE ONE**  
**Name**

The name of the corporation is: **DOMAINBROKER.TV, INC.**

**ARTICLE TWO**  
**Principal Office**

The street address of the initial principal office of the corporation is 2809 W. 15<sup>th</sup> Street, Suite 202, Panama City, FL 32401.

**ARTICLE THREE**  
**Corporate Duration**

The duration of the corporation is perpetual.

**ARTICLE FOUR**  
**Purpose or Purposes**

The general purposes for which the corporation is organized are:

1. To conduct and operate a internet service business;  
to provide and furnish equipment and service.
2. To engage in any other trade or business which can, in the opinion  
of the board of directors of the corporation, be advantageously  
carried on in connection with or auxiliary to the foregoing  
business.
3. To do such other things as are incidental to the foregoing or  
necessary or desirable in order to accomplish the foregoing.

**ARTICLE FIVE**  
**Capitalization**

The aggregate number of shares which the corporation is authorized to issue is **2000**. Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.

**ARTICLE SIX**  
**Preemptive Rights**

Each shareholder of this corporation shall have the first right to purchase shares of any class, kind or series of stock in this corporation that may from time to time be issued, whether or not presently authorized, including shares from the treasury of this corporation, in the ratio that the number of shares they hold at the time of issue bears to the total number of shares by any shareholder who does not exercise it and pay for the shares preempted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting them to exercise their preemptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.

**ARTICLE SEVEN**  
**Registered Office and Agent**
