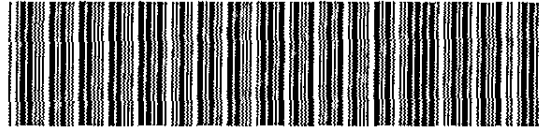

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF

Pursuant to the provisions of section 607.1006, Florida Statutes, ABACOA TOWN CENTER CHIROPRACTIC, P.A. adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The name of the corporation is ABACOA TOWN CENTER CHIROPRACTIC, P.A. (the "Corporation").

**SECOND:** Article I of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

**"ARTICLE I - NAME"**

The name of the Corporation shall be ABACOA TOWN CENTER CHIROPRACTIC, INC."

**THIRD:** Article II of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

**"ARTICLE II - PURPOSE"**

This Corporation is being formed for the purpose of transacting any and all business for which corporations may be incorporated under Chapter 607 of the Florida Statutes, as amended."

**FOURTH:** It is the intent of these Articles of Amendment for the Corporation to terminate its status as a professional service corporation under Chapter 621 of the Florida Statutes, as amended, and to continue its existence under Chapter 607 of the Florida Statutes, as amended.

**FIFTH:** The Amendment was recommended, approved and adopted by the sole Director of the Corporation on March 7, 2003.

**SIXTH:** This Amendment was approved and adopted by the sole shareholder of the Corporation on March 7, 2003.
