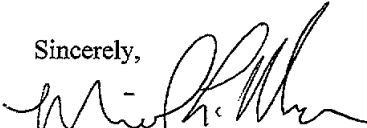

ARTICLE I

Initial Board of Directors

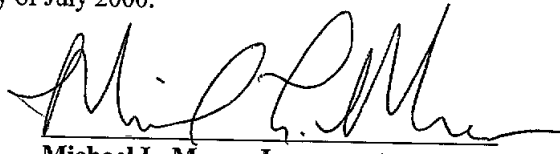
