The duration of the Corporation is perpetual.



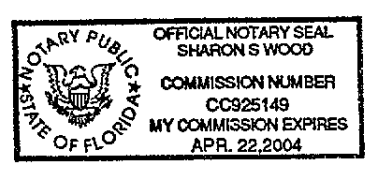
