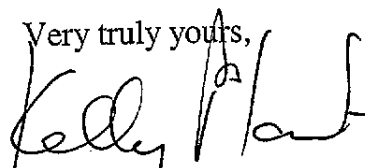

ARTICLES OF INCORPORATION
OF
ARNALL & YORK, INC.

The undersigned, acting as the incorporator of Arnall & York, Inc., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation.

ARTICLE I - NAME

The name of this corporation is Arnall & York, Inc. The mailing address of the Corporation shall be 225 South Adams Street, Suite 250, Tallahassee, Florida 32301.

ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

ARTICLE III - DURATION

The corporation shall exist perpetually.

ARTICLE IV - PURPOSE

This Corporation is organized for the specific purpose of providing consulting services for governmental affairs and, in general, to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

ARTICLE V - CAPITAL STOCK

The maximum number of shares of capital stock that the Corporation is authorized to issue and have outstanding at any one time is Five Thousand (5,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

The Corporation shall have two (2) directors initially. The number of directors may be either increased or diminished from time to time in accordance with the Bylaws, but shall never be less than one (1).

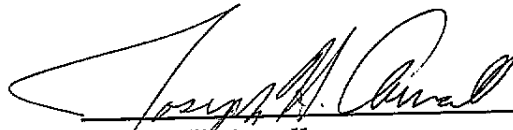
ARTICLE IX - BYLAWS
