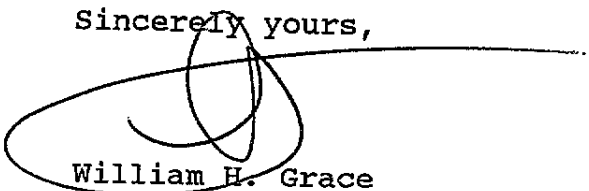

ARTICLE I

(NAME)

The name of this corporation is DeBORD, INC.

ARTICLE II

(DURATION)

The corporation shall exist perpetually, unless sooner terminated according to law. Its existence shall commence upon the signing of these Articles.

ARTICLE III

(PURPOSE)

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

ARTICLE IV

(CAPITAL STOCK)

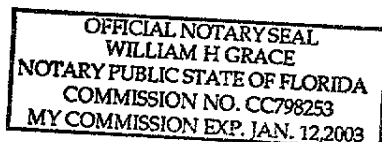
