PREAMBLE

We, the undersigned Subscribers, natural persons, competent to contract, do hereby associate ourselves under the following Articles of Incorporation, and form a Corporation under the laws of the State of Florida.

ARTICLE I

The name of the Corporation shall be MACHINE & TOOL TECHNOLOGIES,

ARTICLE II PRINCIPAL ADDRESS AND MAILING ADDRESS

The principal address of the Corporation is 1425 Meadows Circle West, Boynton Beach, FL 33436, and the mailing address of the Corporation is 1425 Meadows Circle West, Boynton Beach, FL 33436.

ARTICLE III PURPOSES

The purpose for which the Corporation is formed and the business and objects to be carried on and promoted by it are:

Nothing in this Article shall be construed to allow any act of the Board of Directors to be approved by less than a majority of said shareholders or wherever a greater vote is required by law or in the By-Laws, by that vote.

ARTICLE XI TELEPHONE MEETINGS AUTHORIZED

Every shareholder, upon the sale for cash of any new stock of this Corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of

fractional shares) at the price at which it is offered to others.


ARTICLE XV INDEMNIFICATION OF OFFICERS AND DIRECTORS


