ARTICLES OF INCORPORATION

OF

ARTICLE I - CHIP CORLEY, INC., 16 Anderson Street, St. Augustine, FL 32095

The name of this corporation is CHIP CORLEY, INC. and its principal place of busines shall be located at 16 Anderson Street, St. Augustine, FL 32095.
