ARTICLES OF INCORPORATION FOR  
ADVANTAGE MORTGAGE OF BAKER, INC.

I, the undersigned natural person, of the age of twenty-one years or more, acting as incorporator of the corporation, under Florida Business Act, adopt the following articles of incorporation for such corporation:

ARTICLE I - NAME

The name of this corporation is Advantage Mortgage of Baker, Inc, Inc.

ARTICLE II - DURATION

The period of its duration is perpetual existence pursuant to the laws of the State of Florida.

ARTICLE III - PURPOSE

The purpose or purposes for which the corporation is organized are: to engage in any and all business activities or business enterprises permitted under the laws of the United States and the State of Florida; to purchase, sell or hold any and all property, both real and personal and to engage in any lawful business activity, both foreign and domestic.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue 100 shares of common stock at a par value of \$1.00 per share.

ARTICLE V - INITIAL OFFICERS

The principle address and initial registered address and agent of this corporation shall be: 5857 Bush Road, Baker, Florida 32531. The initial agent, Charlotte G. Wadsworth, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.

ARTICLE VI - INITIAL BOARD OF DIRECTORS

Provisions limiting or denying shareholders the pre-emptive right to acquire additional of treasury shares of the corporation are none.

The number of directors may be increased or decreased from time to time by vote of the stockholders, but in no case shall the number of directors be less than one. Bylaws may provide for increase or change in the number of directors.

ARTICLE VII - CUMULATIVE VOTING

SECRETARY OF STATE  
TALLAHASSEE, FLORIDA

Shareholder of this corporation may vote their stock cumulatively. Each shareholder shall have the total number of votes which is equal to the number of shares of stock with voting rights which such shareholder holds multiplied by the number of directors to be elected.

The shareholder may give all of their votes to one candidate or distribute them among as many candidates as the shareholder may wish.

Notice must be given by any shareholder to the President or Vice President of the corporation not less than 24 hours prior to the time set for the holding of a shareholder's meeting for the election of directors that such shareholder intends to accumulate his vote at said election.

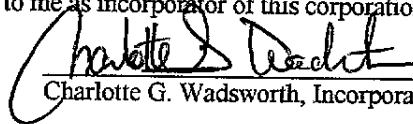
ARTICLE IX - AMENDMENT

ARTICLE X - INCORPORATOR

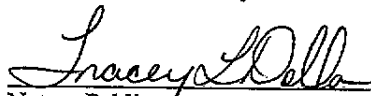
The Incorporator of the corporation is Charlotte G. Wadsworth, and he has agreed to accept the responsibilities that come with this role.
