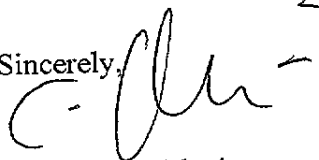

Article XI

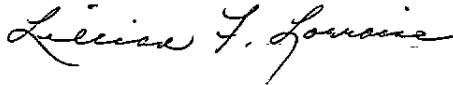
