**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OF  
NANAK'S ORNAMENTALS AND DESIGN, INC.**

These Articles of Amendment to Articles of Incorporation ("Amendment") are filed pursuant to Florida Statute Section 607.1006, to reflect an amendment to the Articles of Incorporation of NANAK'S ORNAMENTALS AND DESIGN, INC., and in connection therewith, the undersigned officers, acting upon authority of the Board of Directors of NANAK'S ORNAMENTALS AND DESIGN, INC., and upon authority of the holders of all of the shares entitled to vote on said Amendment, hereby set forth as follows:

1. The name of this Corporation is NANAK'S ORNAMENTALS AND DESIGN, INC.
2. The Articles of Incorporation of NANAK'S ORNAMENTALS AND DESIGN, INC. have been amended by deleting Article I in its entirety and by substituting in lieu thereof the following Article:

**"ARTICLE I  
NAME**

The name of this Corporation is ORNAMENTALS 1442, INC."

4. Upon the filing of these Articles of Amendment by the Department of State, the above referred to Amendment shall become effective and the Articles of Incorporation of NANAK'S ORNAMENTALS AND DESIGN, INC. shall be deemed to be amended accordingly.
