**ARTICLE I - NAME**

The name of the corporation is South American Gold Traders, Inc. with its principal place of business located at 8905 S.W. 87<sup>TH</sup> Avenue, Suite #200, Miami, Fl 33176.

**ARTICLE II - PURPOSE**




