ARTICLES OF INCORPORATION
OF
ORIGINAL TEAM WRESTLING, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Original Team Wrestling, Inc.

ARTICLE II

The existence of the corporation shall be perpetual.

ARTICLE III

The street address of the principal office of the Corporation is 1133 N. Dixie Freeway, New Smyrna Beach, Florida 32168.

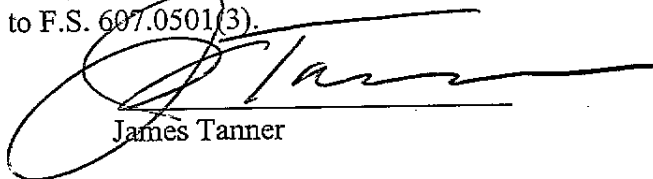
