ARTICLES OF INCORPORATION

ARTICLE I.  
NAME

The name of the corporation is POT DEPOT, INC.

ARTICLE II.  
DURATION

This corporation shall have perpetual existence, commencing on the filing of these articles with the Department of State.

ARTICLE III.  
CAPITAL STOCK

This corporation is authorized to issue ONE THOUSAND (1000) shares of ONE DOLLAR (\$1.00) par value common stock.

ARTICLE IV.  
PREEMPTIVE RIGHTS

ARTICLE VII.

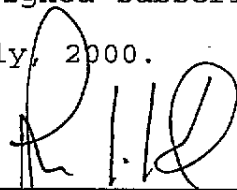
The principal office and the mailing address of this corporation is 17 Palafox Place, Suite 318, Pensacola, Florida 32501.
