ARTICLES OF INCORPORATION OF NVP MARKETING, INC.

ARTICLE I - NAME

The name of this corporation shall be NVP Marketing, Inc.



ARTICLE II - PURPOSE

The Corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.

ARTICLE III - CAPITAL STOCK
