

ARTICLE X



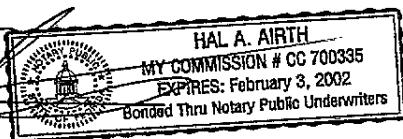
