ARTICLES OF AMENDMENT TO THE ARTICLES  
OF INCORPORATION  
OF  
F. A. PARTNERS, INC.

Pursuant to the provisions of Section 607.181 of the Florida General Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is F. A. PARTNERS, INC.
2. The following amendments of the Articles of Incorporation were adopted by the shareholders of the Corporation on July 27, 2000, in the manner prescribed by the Florida General Corporation Act:

DELETE ARTICLE I IN ITS ENTIRETY AND IN ITS PLACE  
SUBSTITUTE THE FOLLOWING:

ARTICLE I - Name of Corporation. The name of this Corporation shall be: F. A. PARTNERS, INC., 910 East 127<sup>th</sup> Avenue, Tampa, Florida 33612.

DELETE ARTICLE II (1) IN ITS ENTIRETY AND IN ITS PLACE  
SUBSTITUTE THE FOLLOWING:

ARTICLE II (1) To engage generally in the business of owning and operating a company specializing in industrial painting, waterproofing, fiberglass repairs and construction management.

3. The number of shares of the Corporation outstanding at the time of adoption was 625, and the number of shares entitled to vote thereon was 625.

4. The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:
