ARTICLES OF INCORPORATION  
OF

RAVEN CONSTRUCTION GROUP, INC.

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida Business Corporation Act.

**FIRST:** The name of the corporation (hereinafter called the "Corporation") is RAVEN CONSTRUCTION GROUP, INC.

**SECOND:** The principal office of the Corporation shall be located at 19593 Northeast 10<sup>th</sup> Avenue, Bays C & D, North Miami Beach, Florida 33179. The mailing address of the Corporation is 19593 Northeast 10<sup>th</sup> Avenue, Bays C & D, North Miami Beach, Florida 33179.

**THIRD:** The aggregate number of shares which the Corporation shall have authority to issue is 1000, all of which are of a par value of \$1.00 each and are of the same class and are to be common shares.
