## ARTICLES OF INCORPORATION OF ROCKAWAY WHOLESALERS, INC.

The undersigned incorporator hereby makes, subscribes to, acknowledges and files these Articles of Incorporation for the purposes of organizing and incorporating a corporation for profit under the laws of the State of Florida.

#### ARTICLE I
