ARTICLE ONE

The name of this corporation is AAA O'BRIEN AUTOMOTIVE, INC. and the mailing address of the corporation shall be 13081 Metro Parkway, Suite 5 and 6, Fort Myers, FL 33912.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.
