





#### ARTICLE VIII. AMENDMENT



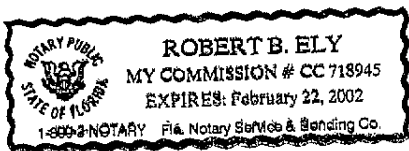
