

ARTICLES OF INCORPORATION OF

ESU VI, INC.

ARTICLE I. NAME

The name of the corporation shall be ESU VI, INC.

ARTICLE II. TERM OF EXISTENCE

The corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation.

ARTICLE III. PURPOSE

This corporation is organized to engage in all business acts authorized under the laws of the State of Florida, and to do any and all acts necessary to the fulfillment of such endeavors.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 100 shares of \$5.00 value stock.

ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial principal office of this corporation is: 3750 Park Central Boulevard North, Pompano Beach, FL 33062. The name and address of the initial registered agent of this corporation is JOSEPH UDELL at 3750 Park Central Boulevard North, Pompano Beach, FL 33062.

ARTICLE VI. INITIAL BOARD OF DIRECTORS

This corporation shall have two (2) Director initially. The number of Directors may be increased from time to time according to the ByLaws. The name and address of the initial Directors of the corporation are JOSEPH UDELL and ELAINE UDELL, of 3750 Park Central Boulevard North, Pompano Beach, FL 33062.

ARTICLE VII. INCORPORATION

The name and address of the person signing these Articles of Incorporation is as follows: JOSEPH UDELL of 3750 Park Central Boulevard North, Pompano Beach, FL 33062.

ARTICLE VIII. BYLAWS

The power to adopt, alter, amend or repeal the ByLaws shall be vested in the Board of Directors and shareholders.

ARTICLE IX. CALLING OF SPECIAL MEETING

Special meetings of shareholders may be called by written notice delivered to each shareholder three (3) business days prior to the meeting date.

ARTICLE X. SHAREHOLDER QUORUM AND VOTING

Sixty six percent (66%) of the shares entitled to vote, represented in person or by proxy, shall constitute a quorum of a meeting of shareholders. If a quorum is present, the affirmative vote of the majority of the shares represented and entitled to vote at the meeting shall be the act of the shareholders.

ARTICLE XI. MANAGEMENT OF CORPORATION BY DIRECTORS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation, shall be managed under the Board of Directors of the corporation.

ARTICLE XII. DIRECTORS' TERMS

The shareholders of this corporation shall be entitled to remove any Director from office during his term.

ARTICLE XIII. DIRECTOR QUORUM AND VOTING

Two (2) Directors shall constitute a quorum for a meeting of the Directors. If a quorum is present, the affirmative vote of the

majority of the Directors present shall be the act of the Board of Directors.


ARTICLE XIV. INDEMNIFICATION

ARTICLE XV. AMENDMENT


