CHANGING CORPORATE NAME

Pursuant to the provisions of Sections 607.181 and 607.187, Florida Statutes, the undersigned corporation, **GEORGE CHACONAS, P.A.**, a Florida corporation (the "**Corporation**"), adopts the following Articles of Amendment to change its corporate name and amend its Articles of Incorporation:

1. **Present Corporate Name.** The present name of the Corporation is:

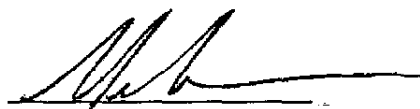

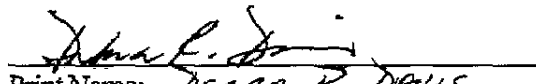
