ARTICLES OF INCORPORATION OF

JAX FIRE CU SERVICES, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLES I. NAME

The name of the corporation shall be:

JAX FIRE CU SERVICES, INC.

The principal place of business of this corporation shall be 7908 Blanding Blvd., Jacksonville FL 32244. The mailing address for the corporation shall be 7908 Blanding Blvd, Jacksonville FL 32244.

ARTICLE IL NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country or nation.

ARTICLE III. CAPITAL STOCK
