This letter is a request to refund the reinstatement fees issued on Doctor of the Century, Inc. A check was cashed in October for \$600 from our company.

The person previously employed as a bookkeeper, Anita King, had been embezzling monies, forging checks and conducting other fraudulent activity since September 2001.

In order to cover the egregious accounting irregularities, the bookkeeper diverted the mail and simply discarded everything from IRS tax returns to the annual report sent from Tallahassee. Further, she set up a P.O. Box and had all mail addressed to Doctors of the Century forwarded to a Postal box to which I have no key, no access. Please confirm that the correct address is on file....6312 NW 42nd Terrace, Coconut Creek, FL 33073.

I, the registered agent, Pamela Rothman, and sole owner, did not receive our annual report. However, in good faith sent in the reinstatement check when the fraud was discovered. My accountant advised me to send this letter requesting a refund, due to the ongoing criminal investigation and due to not receiving the notifications.


Dear Sir:
