In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLEI

NAME OF CORPORATION

The name of the corporation shall be FIRST FOREX HOLDING, CORP. (hereinafter referred to as the "Corporation").

ARTICLE II GENERAL NATURE OF BUSINESS

The Corporation is organized for the purpose of any and all lawful business permitted under the laws of the United States and the State of Florida.

ARTICLE III PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation in the State of Florida shall be: 4500 Harrison Street, Hollywood, FL 33021.

ARTICLE IV SHARES

- A. The maximum number of shares this Corporation is authorized to issue is 100, par value \$.01 per share, all of which shall be Common Shares.
- B. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

Every shareholder, upon the sale for cash of any new stock of this Corporation of C. the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro rate share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE V TERM OF EXISTENCE

The existence of the Corporation shall begin on July 21, 2000 and the Corporation shall exist perpetually.
