# ARTICLES OF INCORPORATION OF INVENTOR'S INTERNATIONAL, INC.

## ARTICLE I: NAME

The Corporation shall be known as Inventor's International, Inc. and shall be authorized to issue 100,000 shares of common stock with a par value of one (1.00) dollar each. The corporation will not commence business until it has received for the issuance of its shares consideration of the value of at least one-thousand (\$1,000.00) dollars.

## ARTICLE II: INITIAL REGISTERED OFFICE AND AGENT
