

ARTICLES OF INCORPORATION



The name of this corporation is Touchdown Food Market #3, Inc.

ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: $2501\ \text{N}$. Dixie Hwy. Riviera Beach, Florida 33404

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 200 shares of \$1.00 par value common stock which shall be designated as "Common Shares".

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT
