ARTICLES OF INCORPORATION OF THE BARAKA GRILLE, INC.

ARTICLE I Name and Duration

The name of the Corporation is The Baraka Grille, Inc.. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Department of State of the State of Florida.

ARTICLE II Principal Office

The address of the principal office of the Corporation is 54 North Orange Avenue, Orlando, Florida 32801.

ARTICLE III Registered Office and Agent

The address of the registered office in the State of Florida is 250 North Orange Avenue, Penthouse Suite, Orlando, Florida 32801. The name of the registered agent at such address is John L. Brewerton, III, P.A.

ARTICLE IV

Corporate Purposes, Powers and Rights

- 2. If any vacancy occurs in the Board of Directors during a term, the remaining directors, by affirmative vote of a majority thereof, may elect a director to fill the vacancy until the next annual meeting of shareholders.

Every shareholder, upon the sale of any additional stock of this Corporation of the same kind, class or series as that which he or she already holds or of any bonds, debentures, or other securities convertible into stock of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro rata share thereof (as early as may be done without the issuance of fractional shares) subject to the same terms and at the same price at which such stock is offered to others.

ARTICLE X Cumulative Voting

At all elections of directors, each holder of Common Stock is entitled to as many votes as equals the number of his shares of Common Stock multiplied by the number of directors to be elected, and he or she may cast all of such votes for a single director or may distribute them among the number to be voted for, or any two or more of them, as he or she may see fit.
