The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, Florida Statutes Chapter 607, hereby adopts the following articles of incorporation.

ARTICLE I:

**NAME**

The name of the corporation shall be Residential Services of Volusia County, Inc. and the nature of the business is operating assisted living facilities.

ARTICLE II:

**PRINCIPAL OFFICE**


