In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Multicultural Resource Center, Inc..

ARTICLE II

The existence of the corporation shall begin on July 26, 2000.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares, with each share having a par value of \$10.00. 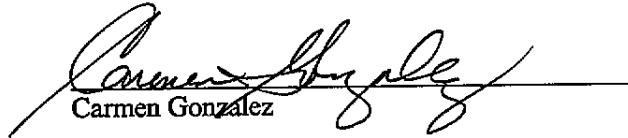

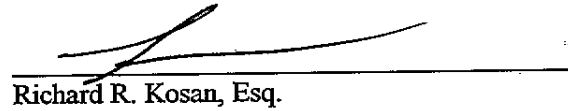
The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
