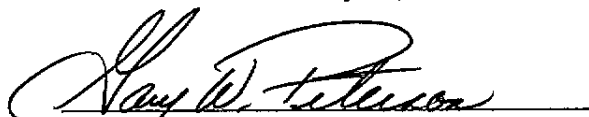

The effective date of this Certificate of Incorporation shall be July 25, 2000.

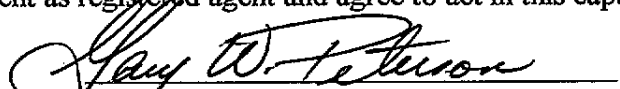
